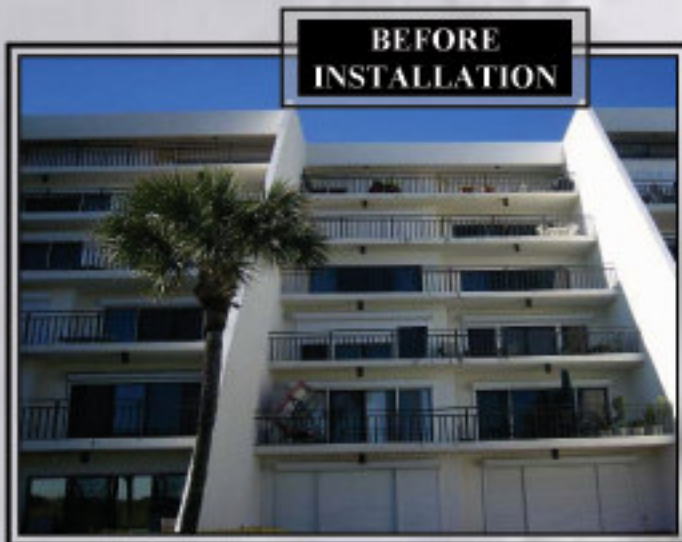

the overall protection of your home during a storm. It deploys quickly and easily, without the use of any tools and folds conveniently for compact storage. Unlike storm panels and shutters, it allows the inside occupants a clear view of the outside of the home.

Traditional rigid systems, of all types, must often be replaced if they are hit with flying debris, while **Hurricane Armor** bounces back with great ease and durability.



*An example of a hurricane protection system featured above.*

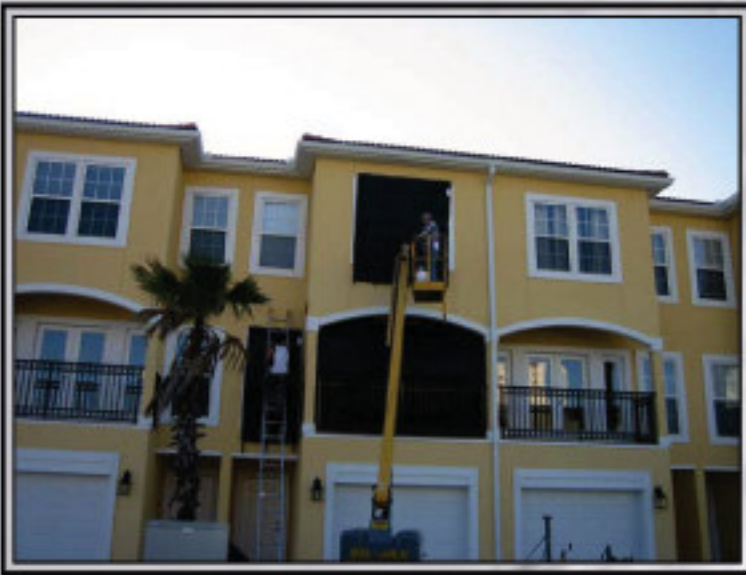

It is a custom created product, installed by certified, trained professionals and comes with a 10 year limited warranty.

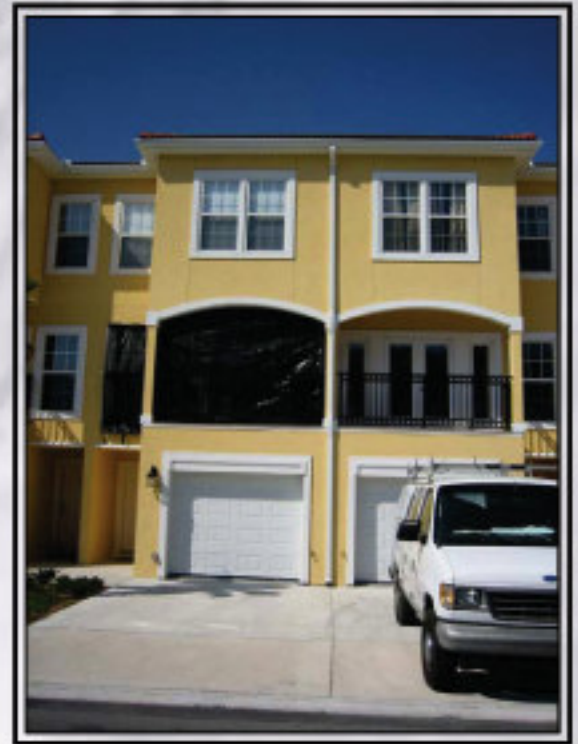
It is also a versatile product, often used to provide additional benefits such as sun screening and daily wind reduction, and is available in a variety of colors that will enhance the exterior color of your home.

Most importantly, the peace of mind for your family, knowing that it will not jam when being deployed in a hurry, is priceless.





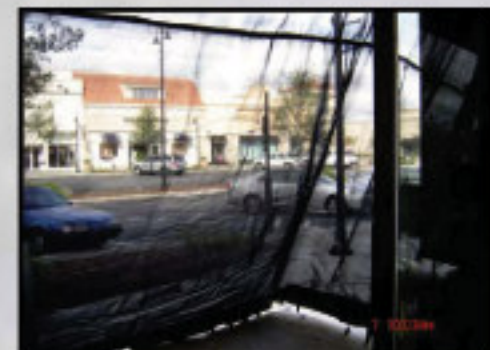
*An example of a private condo residence, showing the coverage provided by a hurricane screen protection system, compared to the neighboring condo next door, which has no protective coverage in place.*
